CORONAVIRUS (COVID-19) UPDATE

Contra Costa County Ready to Vaccinate Children Ages 5-11 Once They're Eligible

Contra Costa Health Services (CCHS) has pre-ordered thousands of pediatric doses of Pfizer's COVID-19 vaccine as the county prepares for federal and state health officials to expand eligibility to kids ages 5-11.

CCHS expects to receive about 20,000 doses of the pediatric version of the Pfizer vaccine for county and partner clinics early this week. Other healthcare providers and pharmacies are also stocking up and getting ready.

This week, the Centers for Disease Control & Prevention (CDC) will be deciding whether to recommend Pfizer's COVID-19 vaccine next week for children ages 5-11. The CDC's recommendation is required before vaccines can be given to this age group. Visit <https://cchealth.org> for more information.

COLLECTION OF BUILDING PERMIT FEES DEFFERED FROM NOVEMBER 3, 2021, THROUGH APRIL 30, 2022

On November 2, 2021, the City Council directed staff to temporarily defer collection of the current Building Permit Fees from November 3, 2021, through April 30, 2022, in order to

allow for a user fee study to be completed and new fees to be established if appropriate. The City's Building Permit fees are statutorily authorized in the Master Fee Schedule, which is adopted by the City Council. The Building Permit fees listed in the current Master Fee Schedule were established in 2012 and were based on the Planning, Building, and Engineering User Fee Study completed in 2008. The fees have not changed since then, however, there has been a recent concern raised regarding parity between Pinole's Building Permit fees and those of some neighboring jurisdictions. To allow the City to look into this issue and complete an updated User Fee Study for the Planning, Building and Engineering Section of the Master Fee Schedule, the City will temporarily defer collection of the current Building Permit Fees under certain conditions.

It is important to note that during this time there are no anticipated delays to the current permit process. The Community Development Department will continue to process, and issue permits subject to an agreement that will allow deferral of fees until after the study is completed. If the owner of the property does not wish to sign the agreement or would like to voluntarily pay Building Permit fees in advance of the user fee study being completed, the City will issue a refund if the new 2022 Building Permit fees are less than the fee paid by the applicant. Regardless, the payment of all applicable Building Permit fees will be required prior to requesting a final inspection. NOTICE TO MERCHANTS -- LICENSE RENEWAL TIME

Attention Business Owners – 2021 Pinole Business Licenses will expire on December 31, 2021. Business license taxes for 2022 are due on December 31, 2021, and become delinquent on February 1, 2022, at which time unpaid taxes are subject to a 50% penalty. There is a change to the business license tax rate for calendar year 2022. The tax for the basic business license is \$152.00 per year (not including the \$4.00 AB 1379 state mandated fee).

Business license renewal forms are being mailed out November 24, 2021, for calendar year 2022. Renewal forms are mailed to you as a courtesy; we make every effort to make sure that a renewal form is mailed to each active business. If you do not receive a renewal form, it is the business owner's responsibility to pay the business license tax by January 31, 2022. Please remit your payment to:
