ITEMS OF INTEREST

CITY COUNCIL ROTATION

On Tuesday, December 7, 2021, the annual City Council Rotation occurred. Vincent Salimi was appointed to serve as the Mayor and Devin T. Murphy was appointed to serve as the Mayor Pro Tem. Devin Murphy was sworn in by Contra Costa County District Attorney Diana Becton; Vincent Salimi was sworn in by Paul Tour-Sarkissian, Esq. These appointments were effective immediately and will run until the first meeting in December 2022. Congratulations to Mayor Salimi and Mayor Pro Tem Murphy.

CITY OF PINOLE PUBLIC WORKS DEPARTMENT STREET LIGHT MAINTENANCE PROGRAM

The City of Pinole Public Works Street Light maintenance program includes a semi-annual survey of the street light system (spring and fall) to identify outages and repair needs and a reporting system to notify Public Works when an outage occurs between surveys. The Public Works Department relies on assistance from the residents and visitors of Pinole between surveys to identify outages and make timely repairs. There are two ways a street light outage can be reported; 1. The reporting party can use the street light outage reporting portal on the PG&E website at www.pge.com, or 2. The reporting party may contact the Public Works Department by one of three ways; a concerned party can call the main Public Works phone number at (510) 724-9010, through the City of Pinole website at publicworks@ci.pinole.ca.us, or by using the My Civic Citizens Request page reporting portal located on the City of Pinole website on the Code Enforcement page under the Citizens Request Page link. By contacting either PG&E or the City of Pinole, Public Works will determine the ownership of the street light and the responsible agency will be notified of the service request for repair.

FOOD DISTRIBUTION

The Food Bank of Contra Costa and Solano County will be providing free boxes of nonperishable food and bags of fresh produce every second Monday of the month. The next drive-thru distribution is on Monday, December 13, 2021, from 9 am to 11 am (or as supplies last) at the Pinole Senior Center parking lot, 2500 Charles Ave. You do NOT need to be a member of the Pinole Senior Center or a senior to receive food. Quantities are limited. First come first serve. One box and/or bag per household. This will be a contact-less event, please follow the directions from staff and volunteers when you arrive. Food items will be placed in the trunk by staff/volunteers. Parking or exiting your vehicle will not be allowed. All participants must follow social distancing guidelines and wear a face covering. NOTICE TO MERCHANTS -- LICENSE RENEWAL TIME

Attention Business Owners – 2021 Pinole Business Licenses will expire on December 31, 2021. Business license taxes for 2022 are due on December 31, 2021, and become delinquent on February 1, 2022, at which time unpaid taxes are subject to a 50% penalty. There is a change to the business license tax rate for calendar year 2022. The tax for the basic business license is \$152.00 per year (not including the \$4.00 AB 1379 state mandated fee).

Business license renewal forms are being mailed out November 24, 2021, for calendar year 2022. Renewal forms are mailed to you as a courtesy; we make every effort to make sure that a renewal form is mailed to each active business. If you do not receive a renewal form, it is the business owner's responsibility to pay the business license tax by January 31, 2022. Please remit your payment to:

Traffic and Pedestrian Safety Committee (5 positions*):

The Pinole Traffic and Pedestrian Safety Committee is a five-member panel who recommend or review action on traffic safety, traffic control and planning, speed limits, parking, and other traffic related matters. The committee makes recommendations to the City Council, committee members service two-year terms.

Community Services Commission (6 positions*):

The Community Services Commission is comprised of seven members who must be Pinole residents. The Commission serves in an advisory capacity to the City Council in matters pertaining to public recreation, parks, arts and cultural activities, historical activities, public access television activities, senior and youth activities, and community services. The Commission reviews and recommends policies and procedures governing recreation, park, and community services for approval by the City Council; maintains relationships with schools, community, and civic organizations; advocates for recreation and community services for the community; and collaborates with civic clubs, nonprofit organizations, and citizen groups to provide funds, property and or volunteerism for the development and operation of parks and recreation facilities. The Community Services Commission meets monthly on the 4th Wednesday at 5 pm. Commissioners service two-year terms.
