## PARTY AGREEMENT

A fee of \$15.00 per guest will be charged if the number exceeds the reserved max, and also if the party goes over given time. **NO ALCOHOL, DRUGS, GLASS, CERAMIC, BBQ PITS, AND/OR TOBACCO ARE ALLOWED IN THE FACILITY.** I have received and will distribute to guests a list of pool and facility rules. I am also responsible for clean-up after the party. I understand that any trash or recycling needs to be collected and taken to the bins/dumpster.

Please bring food already cooked, grills are not allowed on deck. There are no refrigerators or freezers available so please plan accordingly. All parties should be family friendly and suitable for children. All parties are held to a 100 guest max. This includes swimmers, non swimmers and host families.

**\*Fees and cancellation policy-** I understand the payment is due in full upon making the reservation. A credit/debit card must be used for payment and will be kept on file in the event of overage fees. Cancellations must be made at least two weeks prior to the party date. In the event of cancellation, a refund will be issued less a \$50.00 non-refundable, non-transferrable processing charge unless the party has been canceled by the Pinole Swim Center. I understand that the Pinole Swim Center is a community facility and as such, it may have to shut down on occasion with no notice. This type of closure does qualify for a full refund.

I have received the pool party policies from the Pinole Pool representative, and I have read and understand all information provided in the pool policies and on the party flier. I understand that each of my guests must bring his/her own towel as towels are not provided at the swim center. I also understand that we are not allowed to bring flotation devices to this facility. I agree to abide by all the guidelines outlined in this party agreement and the accompanying pool rules.

#### Pinole Pool Party Guideline and Rules

- You may bring your own decorations, but are responsible for clean-up after the party.
- Food and Beverages are allowed (no alcohol or glass)
- No flotation devices, life vests, or swim float inserts, (puddle jumper is ok)
- No refrigeration access
- No pets
- Music is allowed with a city permit, low volume, "clean" lyrics.
- Early entry of 30 minutes for set-up.
- No denim or cotton. Swimsuit material only.
- Please see rule board posted at the pool for specific diving rules.
- Lifeguard has complete and total authority to enforce all rules with the safety of all patrons as their goal.
- **Person responsible must provide proof of liability insurance (as set forth by the city of Pinole). 1 million coverage is needed naming Pinole Seals Swim Club and their employees' as well as the City of Pinole and their employees.**
- I am agreeing to these above mentioned rules and will take all responsibility to inform my guests of these rules.
