Access to trucks with loaded heights exceeding the overpass clearances are prohibited.

1. Permittee shall contact the City of Pinole Public Works Department prior to entering the City Limits and advise us of the date and time that the subject vehicle or load will enter and leave the City and the proposed route to be used. You may notify us by using one of the following means:

2. If the vehicle is entering the City on a weekend or holiday when the Public Works Department is closed, Permittee shall notify Pinole Police Dispatch at (510) 724-8950.
3. The City of Pinole Municipal Code prohibits commercial vehicles over 3 tons gross weight from using residential streets unless a delivery is to be made on a residential street. In such cases, the most direct route shall be used to access the delivery address, and the driver shall carry a manifest or bill of lading indicating the residential delivery address.
4. Permittee shall provide the City of Pinole with a certificate of liability insurance indicating at least the minimum limits specified by the California Vehicle Code. The certificate need not name the City as an additional insured.
5. Permittee shall provide the City of Pinole with the numbers of or a copy of any State transportation permits required for the vehicle to reach the City Limits.
6. This permit is valid only for vehicles and/or loads not requiring traffic control and/or escort by Pinole Police Department or the Public Works Department or moving of any City or utility facilities such as (but not limited to) power lines, telephone cables, traffic signals, etc. Vehicles or loads of such dimensions as to require traffic control or relocation of facilities will have all costs born by the applicant.
7. Permittee shall carry a copy of this permit in the vehicle at all times when vehicle is within the Pinole City Limits. Photocopies or fax copies are acceptable.
